# **Administration Creates** Newspaper 'Crisis'

The University of Hartford administration, demonstrating unusual creativity, has transformed a mildly serious campus problem into an apparent "crisis" situation. To press time, the events leading to this "crisis" went more or less as follows:

In the last issue (Sept. 24, 1969) of the U.H. News Liberated Press, the editor, Jack Hardy, made it quite clear, through several articles and editorials, that he strongly disapproved of the way fraternities operate on this campus. Needless to say, adverse reactions to the issue are expected from the fraternities, and these reactions materialized at the Student Senate meeting the following day. At this meeting, several fraternity members and other incensed persons appeared to air their views on Jack and his newspaper. These complaints were deferred to a Communications Commission meeting (the C.C. is the regulating body for all U.H. publications) scheduled for TODAY, October 1 (unless plans change, as they tend to do, be sure to attend this meeting).

Compared to the problems encountered by the paper last year, including the arrest of the editor and the attempted suspension of the paper by the Dean of Students, this current problem did not seem very serious, and it seemed as though the entire situation could be resolved without too much difficulty. It was only after the administration sensed that the students were about to solve their own problems that, in their usual half-assed manner, they decided that it was the right time for the invention of a crisis situation.

Early Thursday afternoon, a rumor reached the U. H. News

a) the newspapers that had been put in the mail the day before had been removed by Charlie Dwight, the UH Treasurer, without notifying Jack, and

b) there was to be a meeting about something concerning the newspaper (exactly what, nobody was sure) that evening, to which many student leaders had been invited, but of which, again, Jack had not been notified.

A quick visit to Mr. Dwight's office revealed that several items in the Liberated Press had been termed (on the advice of UH's lawyer Atwood Collins) "potentially libelous."

#### POTENTIALLY LIBELOUS???!!?

ANY charge against anyone is "Potentially libelous." The only time a problem arises is when the charges are unfounded and the maligned party decides to take legal action. Did Mr. Dwight have any reason to believe that the allegations were unfounded? No, he said. Did, then, he know of any planned legal action stemming from the portedly from Chancellor Woodlegal action stemming from the allegations? Again, no. Then WHY

per as libelous?? The subject changed quickly. The purpose of the meeting that night was not, he said, to determine if any libel had occurred, but because the University was concerned that someone might sue the school for some future libel by the paper. Mr. Collins had informed them that this might be possible, and according to Mr. Dwight and later Dr. Komisar, the sole purpose of the meeting was going to be to discuss how the University could be protected from being sued for indiscretions by the newspaper.

Well, there was a meeting Thursday night officially an open meeting of the Faculty Senate. The purpose of the meeting, as best as this reporter could see, was to determine the purpose of the meeting. Various charges flew back and forth: Jack accused the administration of inconsistancy, Dean Sweeney accused Jack of irresponsibility, NOBODY accused Jack of libel, Clement accused the administration of acting in bad faith in not allowing the Communications Commission to meet first, Angelo accused the University of racism "I don't take that charge lightly," said Dwight, "Well, I meant it heavily," said Angelo). The only decision reached was the long awaited decision to adjourn the meeting.

On Saturday afternoon, Sweeney notified Bill Clement, Communications Commission chairman, that he wanted to meet with the Com. Com. Sunday morning at 11:00 to discuss some mysteriously unspecified new developments. At the meeting, Sweeney and Professor Holder of the Business School, presented the "new development" - an unsigned letter, noticeably

did he incessantly refer to the pa- ruff. The Chancellor was writing from his hideout in New York to tell us that he had heard from Mr. Collins that due to Jack's "irresponsibility," there was a chance that UH might lose its \$5 million libel insurance policy. In order to prevent this, the administration wanted Jack to look into the possibility of forming the paper into a separate corporation, "Fine," said Jack. How much time do we get? "Oh," said Mr. Holder, "I'd say about 48 hours."

#### FORTY-EIGHT HOURS!!!

Catch this: the administration wants the paper to form a corporation in TWO DAYS!! This does not, of course, leave much time to do a number of things: talk to the Board of Regents, who indirectly license the paper; consult a lawyer to make sure the incorporating procedure is correct; consult the SA, the body that controls the paper; consult the students who pay for the paper. Incorporating is a major step and all

possibilities should be carefully explored.


What happens if the paper doesn't incorporate in two days? "Well," says Mr. Holder, "action might have to be taken to make sure the next issue doesn't get published."
"Is that a threat?""Of course not," says Holder.

OF COURSE IT IS! It is high time that the administration keep out of student affairs. Sweeney should have learned that last year when he tried to suspend the paper. The administration MUST be taught that the student body will not let itself get pushed around.

And don't be fooled when the administration tries to blame everything on Jack. If a crisis exists, it is only an artificial creation of the administration. DON'T BE FOOLED!




Paul Tieger presents opposing view.

# Dick Gregory-Speaks At UofH

Dick Gregory will be appearing Monday evening, October 6, at 8:30 in the University of Hartford Gymnasium. Gregory is an author, a comedian, a lecturer and an actor. But he is an active stimulus in drawing attention to the problems of the oppressed minorities in this country. He is a man with a message. A message of freedom and equality not only for the Negro but for the entire human race.

"This is a revolution. It started long before I came into it, and I may die before it's over, but we'll bust this thing and cut out this cancer. America will be as strong and beautiful as it should be for black folks and white folks. We'll all be free then, free from a system that makes a man less than a man, that teaches hate and fear and ignorance."

Gregory has spent more time in southern jails, marched in more demonstrations, prevented more racial violence and worked harder for the rights of the Negro than any other entertainer in America. His autobiography "Nigger," has become a best seller and his new book "Sermons" will prove to be an even greater success. He is a soldier in a war against hate and bigotry with weapons that include a complete personal dedication of his talent and a razor sharp sense of humor.

Named as the man most hated by the Ku Klux Klan he affirms, "They're so out of style, I think they are the only people in the country who aren't using colored sheets."

His life is a consistency of "one nighters." With suitcase in hand, he lives en route, stopping to play countless benefits, deliver church sermons, lobby in Washington and speak at universities throughout the country.

"You didn't die a slave for nothing, Momma. You brought us up. You and all those Negro mothers who gave their kids the strength to go on, totake that thimble to the well while the whites were taking buckets. Those of us who destroyed got stronger, got calluses on our souls. And now we're ready to change a system where a white man can destory a black man with a single word. Nigger."

1. "The film on pot was elementary and uninformative." "I used to be against the use of pot; now I firmly believe that it should be legalized." "Man, it was out of sight." 2. "The film on acid was extremely one-sided." "The experiments used to test the dangers of LSD were not scientifically valid."

"There was too much speculation inserted instead of fact."

3. "That chick chose to use drugs as an escape, rather than as a catalyst for happiness." "She had

little strength.' Due to the varying opinions, I feel that is is necessary to state some of the important facts that were contained in each film. It is, therefore, left up to each individual todecide for himself how serious the drug issue is today. a) In "POTpourri," the audience shown how is very skillfully marijuana is grown, sold, and used. The "high" that smokers get from the drug is explained by the users, captured during group interaction by photographers, and analyzed by psychiatrists. The only physical reactions to pot, however, were the increase of both appetite and pulse beat. The specialists say that pot makes one "look into oneself," thus, a user may become extremely depressed and resort to suicide. Users said that pot

was useful to the individual bebecause it temporarily stops the monotony of everday life, allows one to escape the "ugly society," and helps one to know himself better.

b) In "LSD: Insight and Insanity", the viewers are immediately faced with users having bad trips or known as freaking out. Through cinematography, one is shown how vivid and complex are the colors and figures that a person, stoned, sees. Serious claims that acid causes chromosomal breakage, and possibly cancer, were then made by scientists who had conducted experiments in animals, when injected with a moderate dosage of LSD, all produced abnormal feces with various missing faculties. Specialists concluded that, "No drug that has been tested is as harmful as LSD; it is a dangerous as Russian Roulette." c) In "Escape to Nowhere", the audience was shown how a sixteen year old New York girl becomes addicted to everything from pot to heroin in search of happiness. She was unaffected by all the scare tactics used to discourage drug abuse. Now. she was lonely, ambitionless, and confused. She states: "I only started to use pot to calm down - I never anticipated that I'd be shooting heroin one or two times a week." only wish is to be a child again,

free of all problems of life."

She concludes her story with a continued on page 8

# Boycott Grapes!

Issues are exciting only when they are fresh; new. And today, conflicts which aren't colorful and violent are soon passed over in favor of "better copy." The United Farm Workers have been on strike against the grape growers in Delano, California for too long. Have you forgotten them?

Farm laborers are perhaps the most oppressed workers in America. Wages, housing, working condions are all below minimal Federal levels, and are not governed by Federal labor laws. California grape growers are able to hire non-union labor at cruel prices, completely controlling the market. Caesar Chavez has been leading a strike at Delano, supported by the late Robert Kennedy, and there is a nation-wide movement to boycott supermarkets and liquor stores which sell grapes and wines from California fields. But too many

have forgotten.

U.F.W. are boycotting stores in the Hartford area, stores which continue to sell grapes and hire non-union labor. This weekend, they were at Mott's in West Hartford, with signs and literature designed to inform people of the movement. Their object is not harrassment, but information. The John Birch Society was there, too, warning people of the "Marxist tactics" being used. But the West Hartford housewives didn't care. They had forgotten.

Caesar Chavez is coming to Hartford on October 13. If anyone can keep the memory of Delano alive, it is this shy, quiet and yet charismatic man. Come and see him. Learn if you cannot join; know if you cannot support. Do not forget.

# **Community Renewal Team**

POVERTY is never having enough. Poverty is always running out of money, of food, or clothes, of fuel, of soap, of bedding, of equipment, of room, of medicines, of time, of anyway to go any place, of anything to do anything with, of any way for the family to stay together and live.

Too many people tend to forget that there is another minority group in Hartford beside the Blacks. A minority of people who are United States citizens yet have no representative on City Council. The official census states that there are 19,000 total Puerto Rican and Spanish speaking people in Hartford. The actual number is closer to 24,000 adults, of which only 3,700 are registered to vote. Lacking political power, the Puerto Ricans are the forgotten people among the paper shuffling bureaucracy.

South Green Multi-Service Center is a division of the Community Renewal Team located at 99 Main St. around the corner from Park St. It is a non-political, non profit organization under the Office of Economic Opportunity that is working to help people help themselves by instilling an upward mobility in them. Community Renewal Team offers people aid in getting jobs, health services, legal services, and any problem that a person could possibly encounter.

Many of the Puerto Ricans who consult C.R.T. have been in the United States a month or less and are still adjusting to the social factors of the daily life situation, in addition to the language barrier, discrimination, diet change and temperature change.

C.R.T. job counselors treat the "total" person's unique problem. Their approach is a multi-faceted one in that they cover economic, educational, sociological, occupational, and psychological prob-lems. After defining the entry skill level of the clientele, the job counselor matches the function level and job requirements.

Some employers insist upon high school graduates, C.R.T. points out that according to a national study, the majority of high school graduates in the United States function on an 8th grade level in most areas and even below that in mathematics. A high school degree doesn't identify the credentials let alone the function level of the indivi-

C.R.T. more than doubled the first seven months figure of job placements with a total figure of 185 placements of two job counselors. With each applicant that is hired, goes a "follow up" procedure, 'follow through" (after 3 days) "follow up" (1 month) and "follow out" (3 months). This system is an attempt not only to keep tabs on referrals but to build a rapport with the employers. During the "Follow Up" stage, C.R.T. asks the employer about incentives and goals of his program plus new openings.

Also offered is a Legal Service consisting of a rotating pool of 72 lawyers who offer their services for all non-criminal cases including breach of peace, legal separations, divorces and civil

1. pinpoint the health programs of each person applying for work

while establishing employability.


2. have the family heads bring their families in for a health span
-- referring their medical needs to the proper channels

3. train three field workers to outreach into neighborhoods and identify health problems of the Poverty Target Area residents.

It has been found that in addition to the normal health prob-lems in the Hartford area, the Puerto Ricans have an acute problem with parasites. Of 365 physicals taken in the Poverty Target Area, over 50% are infected with some type of worm. One of the more harmful diseases is Schistosomiasis-Beclhazia. It occurs in the large intestine and during gestation the worms climb to the liver and cause inflammation, scar tissue and serious liver disease. It has been found that approximately 13% of the Hartford Puerto Rican population has Schistosomiasis. This would normally constitute an epidemic -- but nobody thinks of Puerto Ricans.

To qualify for aid from Community Renewal Team, a person must live in a Poverty Target Area. In the South Green area this would include South Green, ABCD Charter Oak Terrace and Sheldon Charter Oak, All the services are free and include job training programs, language programs sewing and other services, many of which





are donated by individuals. Most people hear about South Green by word of mouth. It takes care of about 500 people a month. C.R.T. needs more Health care workers to outreach the neighborhoods to identify problems, make immedi-

ate adjustments in homes, and make referrals to much needed Health Care Units such as the University of Connecticut-McCook Hospital and the Hartford Dispensary.

# **UofH Launches Special Program For Students In** "Up With People"

The University of Hartford has variety of existing university prolaunched an experimental educational program to provide special on-the-road" college instruction for young men and women traveling throughout this country and abroad with the "Up With People" program

Dr. A.M. Woodruff, UofH chancellor, announced today that approximately 45 members of the "Up With People" cast have been enrolled as special students, to pursue college studies through the University's School of Arts and Sciences during the current academic year.

According to Dr. Woodruff, the program will enable these students to undertake college studies this year while continuing to travel with the 120-member "Up With People" cast. The itinerary for the cast includes shows in Vermont, Pennsylvania and Washington, D. C., during the first semester, and performances in France, Belgium and Switzerland during the second semester.

The new program has been designed to meet the standards established by the University for its regular academic programs, Dr. Woodruff noted. The dean and academic department heads of the School of Arts and Sciences have complete jurisdiction over faculty selection, curricula, and examin-

Chancellor Woodruff stated that the University this year plans to study carefully the progress and results of this special educational venture to gain insight into possibilities for travel by faculty and students in connection with a

grams.

Faculty members this first semester include three full-time members of the University faculty, who will travel to meet the cast in communities on the itinerary and conduct classes there. Three other qualified teachers traveling with the group have been named as adjunct faculty members of the University and will conduct courses under the direction of UofH academic department heads.

Frequent visits to classes will be staff made during the first semester by other faculty, deans and department chairmen to review the progress of the program, said Dr. Woodruff. Also, occasional guest lecturers and specialists from colleges and universities in the areas where the traveling group will be performing will be invited to teach classes.

In addition to the "on-the-road" schedule, these students will also participate in the regular fiveweek 1970 Summer Session, in residence at the University.

The faculty members conducting on-the-road" classes will plan the educational experiences of their students to take advantage of the special opportunities offered by the varied locales in this country and in Europe to be visited by the

During the first semester, studies will include history, philosophy, psychology, American literature, composition, speech and drama, and French.

John Balmer, associate professor of speech and drama in the School of Arts and Sciences, will

conduct a Television Workshop for the special students. Prof. Balmer, who received his undergraduate education at Brown University and his master of arts degree in drama at Wesleyan University, has been a full-time faculty member at the University since 1946.

Miss Virginia Arens Shea, an instructor in the University's English Department, will teach composition and literature. Miss Shea received the bachelor or arts degree in English literature from the University of Hartford and the master of arts degree in English from Temple University. She has completed her course work toward doctorate in English literature at the University of Connecticut.

Another full-time staff member of the University's English department will teach American li-

The three "Up With People" members who have been named to the UofH adjunct faculty for this special program are:

Dr. Morris H. Martin, who will teach History of Civilization and an introductory course in philosophy. Dr. Martin is a graduate of Wadham and Merton Colleges, Oxford University, England, and was one of the youngest men ever to be awarded the degree of Doctor of Philosophy at Oxford.

Miss Ruth Buescher, who will teach Introduction to Psychology and Psychology of Adjustment. Dr. Buescher received her undergraduate education at St. Francis College, Fort Wayne, Indiana, and her masters degree and doctorate from Fordham University. Her previous experience in the field of education includes teaching in Fort Wayne and New York City, as well as social work for the Head Start Program.

Miss Tova Duncan, who will teach French. Miss Duncan received the bachelor of arts degree from the University of California at Berkeley and did her graduate work there and at the Sorbonne.

She teaches the integrated multimedia St. Cloud method of language instruction developed by the French government.
"Up With People" is an inde-

pendent, non-profit organization which provides young people with the opportunity to develop their potentials by writing, producing and staging musical shows and from the educational experience of travel in this country and abroad. The organization currently has three traveling casts.

The young men and women in the program do not receive any salary for their participation and must provide for their own personal expenses. Members of the various casts stay in private homes in the communities they visit. Travel expenses are met primarily through gate receipts from their performances and the sale of re-

An estimated 90 million people in the United States have viewed four "Up With People" television specials. Over five million people have seen the "Up With People" shows in live performances in 49 states, including special perperformances at Carnegie Hall, Hollywood Bowl, Los Angeles Music Center and Constitution Hall in Washington, D.C.

In addition the "Up With People" shows have traveled to 25 nations at the invitation of government and national civic leaders.

# Alice's Cookbook

In order to supplement the drab diet of the University cafeteria or better known as the chemical miracle of Hartford, it has been decided that a cookbook of culinary delicacies will be published in weekly, if possible, sections. The connoisseurs of UofH have feasted on these delights before, but have always wondered how to prepare them. As we all know a chef never reveals the recipe. The actual nutritive value of many of the upcoming treats is dubious, but the one most agreed upon aspect is that they are unique. In some cases they may be breathtaking, possibly on a permanent basis. But what the hell. In closing, I remind you that the secret of a good cook is a good recipe. But if something goes wrong the author cannot be held liable.

Recipe #1

Most people who have been to Mexico know of the native mind blower, peyote. Peyote is a cactus that grows all over the desert and if prepared properly makes a neat dessert.

1) Obtain 50 grams of dried peyote cacti and put into a medium

2) Add 8.5 ounces of 190 proof alcohol and cover bowl tightly, Allow to sit one day with occasional stirring.

3) Filter the mixture and save the filtrate, the stuff in the filter. 4) Soak this in 3.4 Ounces of 1 normal hydrochloric acid, for two hours.

5) Allow the liquid from part 3 to evaporate and leave a resi-

6) Filter part 4 and discard the residue. Combine the HC1 with the residue from part 3 and filter

7) To the solution add, drop by drop, just enough 2 normal potassium hydroxide to make the solution neutral, pH 7.

8) Add 3.4 ounces of C.P. choloform, stir and let mixture separate into two layers. Decant the chloroform layer and discard; save the water layer.

9) Evaporate to a gummy residue. Dissolve in chloroform and filter. For best usage apply intiny drops below the left nostril.

#### The Value of Fraternity and what it means to you

The fraternity system has both its defenders and its opponents. Administrators, faculty, and others debate its advantages periodically; However, rarely is anything published which outlines the real value that students and alumni receive from their fraternity affiliation. This article is not so much a defense as it is a presentation of the facts and figures describing what a fraternity can mean to its members

Membership in an organization which has chapters and alumni throughout the United States and Canada can be a very moving experience. North American students today are far more mobile than those of days gone by. Many move from a Liberal Arts College of their original enrollment to a cooperating institution where they might complete specialized curricula in engineering, medicine, law, or business administration. A significantly growing proportion go on for graduate work after obtaining a Baccalaureate Degree.

Of all the campuses in the country (about 1,546 grant Baccalaureate Degrees), over 1,000 now have Greek - letter societies, 280 more campuses than in 1956, Barring overlap of those who belong both to honorary and social fraternities one out of every 20 Americans is Greek-Letter affiliated. Of the 61 general fraternities, there are 260,000 undergraduates and 2, 998,000 living alumni. Over 70,000 were new initiates last year.

Although only 20% of the nations college students are affilia-

ted with a general Fraternity such ours, three quarters of the Chief Executives of this country's 750 largest corporations are members of Fraternities. It is ob-vious that three quarters of the Presidents of our leading industries, chosen from only 20% of the male college graduates are a select group indeed.

Every president of the United States born since 1825 except two has been a member of a Fra-ternity. Every Vice-President of the United Stares born since 1825 except two has been a member of a Fraternity. One hundred members of the President's Cabinets (out of 158) during the past 60 years have been Fraternity members, as well as 40 justices of the Supreme Court (out of 47) since the Civi. War. In the 90th U.S. Congress, 80% of the senators and 39% of the representatives were members of National Fraternities and Sororities. This is eminently higher than average when one notes that only 20% of the male college graduates have been affiliated and that about 10% of the Senate and 20% of the House have had no college education or only brief college attendance. Furthermore, a number of our National law-makers graduated from institutions where no fraternities or sororities existed.

Almost half of the Governors of our states are Fraternity men; 79% of all who attended colleges where there were undergraduate Fraternity chapters were mem-

The U.S. office of education, hardly a pre-fraternity source, associates Fraternity membership with presistence to graduation. It is expected that one half of those who matriculate at an American college will graduate. On those campuses where there are no Fraternities 33% of the men will graduate. On these campuses where there are no Fraternities, of the men who do not join, 47% will graduate; and of the men

who join National Fraternities, 59% will graduate.

Fraternities help one become the "uncommon man". They are the last stronghold of independent living in the highly organized university and college where one's complete life is dominated by university activities. When the Fraternity does its job well, it cannot be outdone by the dormitory be-cause of the freedom and more importantly, the responsibility it affords. If this image is fulfilled conscientiously by its members, the Fraternity grants to its members more than is available to the average man. A Fraternity is an adjunct to college and university education. It takes over where the university role leaves off. It is an Experience where value is inherent". It is a laboratory for life,

The Fraternity is an experience in living together and sharing maintenance, self government, and personal relations in a community that profits socially and intellectually. The Fraternity contributes the polish that a man desires in his late adolescent years. teaches social graces, leadership, preparation for a job, the significance of understanding other personalities and of being compatible with them, and the ability to operate a household in preparation for ones own life after college. The member contributes service and is taught to understand a truly professional way of life after college. The figures tell us that college Fraternity is a major, positive institution in American college life and has contributed more than any other organization to the ultimate success of American youth.

One of the sharpest attacks on the Fraternity system in recent years has been its alleged discriminatory practices. We in Tau Epsilon Phi can be proud that at no time in our history did we dis-criminate against any one by reason of race, color, or creed. We were founded as a non-denom-inational and non-sectarian Fra-ternity; as our Creed states... we judge our fellows not by their rank nor wealth but by their worth as men..." Religious or racial discrimination has no place in the Fraternity system and is rapidly disappearing.

We believe that public dissemination of the above facts are long overdue. Our members, and indeed the general public should be aware of all the advantages of Fraternity membership and particularly membership in Tau Epislon Phi.

#### Marijuana Law Invades Privacy

There are several ways in which legalization of marijuana is being attempted currently, the most popular being that it is harmless. Cases involving the testimony of doctors, psychologists, sociologists, police officers, and PTA of-

ficials have been struck down when the government says that its use aggravates hangnails. The validity of legalization will never get anywhere on this basis -- how could one legalize cigarettes or lipstick from this approach? The government doesn't have the burden of proof; the defendent does, and the government can always find some vagary.

But it should be clear that the marijuana law for possession is an invasion of the citizens' privacy, and, therefore, is in violation of his constitutional rights. The right to possess marijuana has been asserted in a brief filed this summer in the Colorado Supreme Court. The ACLV of Colorado intends to have the court rule that classification of marijuana as a narcotic is "medically indefensible and sociologically unwar-ranted," and the prosecution for its possession is an invasion of privacy. The brief claims that there is no substantial evidence that its prolonged use leads to physical, mental, or moral degradation, and there is no established connection between its use and anti-social conduct. Furthermore, "the imposition of criminal sanctions on the possession and use of marijuana is an unwarranted and unjustifiable denial of man's innate freedom to experiment with his own consciousness as long as he does no harm.

In a recent Supreme Court decision, Stanley vs. Georgia, it was held that the mere private possession of obscene material cannot constitutionally be considered a crime. In this case, a man's house was being legitimately searched by police, who were seeking evidence of book-making activities, and found pornographic In defense of the right of films. privacy, and in accordance with the first amendment, the Court held, "If the first amendment means anything, it means that a state has no business telling a man, sitting alone in his own house, what books he may read, or what films he may watch. Our whole constitutional heritage rebels at the thought of giving the government the power to control men's minds." The Court also added, however, in anticipation of what claims might be made concerning what kind of conduct would now be permissable in the privacy of one's own home, that, "What we have said in no way infringes upon the power of . . . government to make possession of other items, such as narcotics. or stolen goods a firearms,

crime."

The courts are obviously very cautious in defining rights of conduct in private. This has always been the case; the right to include marijuana will have to be fought for. The ACLV pointed out also that the state already has sufficient legislation to control any public harms related to marijuana, like selling it, or driving while under its influence" to add as a crime the mere possession is an arbitrary and unjustified invasion of the individual right of privacy."

Since the public welfare regarding the possible hazards of marijuana is not affected by its private use, prohibition of private use is an invalid extension of the state's police power.

The brief further claims that the laws represent cruel and unusual punishment (simple possession of marijuana in Colorado is punishable by fines of up to \$10,000, and imprisonment for not less than two years and not more than fifteen years, even for the first offense.) The difference between the seriousness of the crime(?) and the seriousness of the sentence makes it in violation of the eighth amendment.

statement stating that she was too far into drugs to stop now; yet, as one ex-drug user states at the end of the film, "Search for happiness is an expression of heart, not mind."

II. Tuesday night's program included two guest speakers who were well learned in the field of drug abuse, Dr. Carl Nieforth, scientist at the School of Pharmacy at UConn, and Sergeant Tom McDonald of the Connecticut State Police.

Dr. Nieforth stressed upon the effects of marijuana on a person. He stated that the effects of pot is a "learned effect;" in other words, a person sees how other people act when they are "stoned," and thus, acts accordingly when he tries the drug for the first time. He added that two joints generally effect an individual in the same manner that eight ounces of alcohol would. The most detrimental effect of pot is that the user tends to fixate his eyes on one object. The doctor also stated that LSD use has been cut down considerably due to the more abundant supply of grass."

He concluded his lecture, which was more informal than factual, with the results of three studies that were done on LSD. The first stated that LSD was safe, the second stated that LSD improves driving ability, and the last stated that LSD causes birth defects. He stated, however, that none of the studies done were accepted as scientifically valid on a complete basis. In answer to a question concerning the legalization of marijuana, the doctor stated, "Before legalization, a drug must be proven safe, as well as, efficient."

Sergeant Tom McDonald's lecture, however, proved to be typical and uninteresting. He immediately offended the audience by stating the following sentence: "If you guys could come with me to visit the hospitals, where hundreds of young people are painfully trying to recuperate from strong drug habits, you would go to a barber and stop looking like bums." This presentation was hardly the proper way to address a group of people who were interested in learning the facts about drugs. The narcotics agent, therefore, scored very low in the interest and respect of his listeners.

Mr. McDonald, however, had a copious amount of new methods that he uses in confiscating drugs. The use of a specially trained dog has helped the Connecticut State Police more than the combined efforts of all its narcotics agents. This "crafty canine" has been taught to find drugs in every possible place" "No matter how well hidden the dope is" states the sergeant, "he'll find it." What does the dog do when he finds it?--eats it, of course.

Wow! What a waste.

III. Wednesday night's program, the last of the three day symposium, presented Dr. Donald Louria, expert on drugs, author of the book entitled "The Drug Scene", and co-author of "Nightmare Drugs." Doctor Loria opened his lecture with the affirmation that he was not a member of the "blaunchy establishment," but that he was solely interested in correcting drug abuse, for more deaths are caused by drugs than the combined fatalities of accidents and war.

Since Dr. Louria is extremely interested in the use of LSD he stated the following true facts concerning this drug:

1) "LSD, although taken on only 1 occasion, can cause bad recurrences for a period following up to three years after taking the drug. 2) It has been definitely proven that this drug causes chromosomal breakage, as well as chromosomal rearrangements—the former may repair with time, but the latter causes permanent damage.

3) Leukemia has also been linked to the use of LSD. 4) Evidence also suggests that LSD can cause other diseases.

other diseases.

In a radio discussion with Tim-

othy Leary, a firm believer in the LSD Philosophy -- Dr. Louria debated the harmful effects of LSD with his most prominent opponent. Dr. Leary rather submissively admitted that LSD can be dangerous, a major contradiction to his previous teachings.

In relation to the pot problem, Dr. Louria told of the dangers of relation to the different reactions that individuals sustain through constant use, "Marijuana," he states, "most often leads to the use of more potent drugs in order to achieve a better 'high'." A user will lose control of the drug when used on more than 10 occasions. There is, however no chromosomal damage through using pot; yet, the difficulties are now being tested more thoroughly.

Dr. Louria concluded his lecture with a reference to the Woodstock Festival. "It has been proved that 45,000 young people were stoned at Woodstock; thus, the peaceful crowd refrained from damaging property and fighting. Yet, I feel this is a fake interpretation by the festival's officials because a stoned society is not a stable one."

When asked if pot should be leagalized, the Doctor answered, "Why add another evil to our society?"

# Sports Car Rallye



### Hawks Down Rutgers In Opener, 30-6

The UHa football club displayed a well balanced attack in beating the team from Rutgers of Newark last Saturday in New Jersey. It was the first game of the season for the Hawks and the first game ever for the newly formed Rutgers squad.

Over one hundred Hartford rooters were treated to a devestating running game featuring Dave Smith, Jack Jenkins, Relly Nadler, and Mark Adams, and a stingy defense which didn't give up a score until the final three minutes of the game.

Offensively, the Hawks were unstoppable. They scored once in each period with first-year end. Tom Sanders, contributing fourteen points.

Mark Adams started at quarterback and hit Sanders with a 25 yard pass in the second quarter for the second TD of the game. Admas also recorded the third touchdown of the day on a keeper from three yards out.

The tempo of the game was fast as both teams hit hard and tempers flared on many occasions.

The first break for the Hawks came after their first series of downs. Unable to move, they were forced to punt, but defensive back, Paul Britto, raced downfield and hit deep receiver, Nat Johnson, just as he touched the ball, causing him to fumble. Hartford tackle, Paul Rowean, fell on it and the Hawks took possession at the Raiders' twenty.

Jenkins, Smith, and Nadler, worked the ball down to the goal line with Nadler finally going over from the three. Adams pass for the extra points fell incomplete, but the Hawks had a 6-0 lead.

Throughout the contest the Hartford defense was strong and gave up yardage very grudgingly. Continually the Raiders found themselves running three plays and having to punt. The furthest Rutgers was able to penetrate in the first half was to the Hartford 25, but there the defense forced a fumble which lineman Desmond Leahy fell on for the Hawks.

Hartford returned strong after half-time and scored on its first set of downs. The drive found Mark Adams picking up twenty-five yards on two running plays to the home team's twenty. The Hawks inched their way in and Adams went over from the three. Quarterback Bob Jurist came in for the extra

points try and hit end Tom Sanders in the end zone for the conversion and an insurmountable 22-0 lead.

In the fourth quarter the hometown Riaders fought desperately to get on the scoreboard, but the Hawk secondary, led by Mark Greenberg, Henry Naploeon, and Paul Britto, was everywhere, tackling outside runners and deflect-

Rutgers finally did score on an eighteen yard pass play from quarterback Frank Louie to tight - end Jim Phipps. But by this time Coach Worth was freely substituting and the game had long since been decided.

Hartford had scored its final touchdown a few minutes earlier on an eight yard Jurist to Sanders pass. The conversion was good on a freak play which found tackle Joe Morley catching a deflected Jurist pass.

The final score was a decisive 30-6. The football club's second contest and first home clash of the season will be next Friday night (Oct. 3) at Dillon Stadium at 8 o'clock against the much improved New Haven College club.

#### Next week: soccer roster Soccer Team Falls To WPI



The U of H Soccer team opened its season Saturday with a game against WPI, and came back with a resounding 5-0 defeat. It was a rather dismal beginning for a team whose prospects seemed so promising. There was no doubt that the Hawks were far outclassed with both offense and defense being remarkably disorganized. But despite this disappointing setback, there still may be cause for optimism. Several of the players did play an excellent game, particularly Andy Nikin, Bili Stockbridge, and Steve Karamesinis. A good effort was also put forth by Mike Yavner and Rich O'Shaughnessy. Even the three goalies did a creditable job, if you disregard the five goals.

But the main problem was obviously a lack of communication. When a player scores against his own team, and the team starts the half with too many players on the field, it's clear that somebody isn't getting through to somebody. One inexcusable difficulty was the lack of team work, the main reason for the poor offense.

After the game Coach Pastor tried to explain the loss. He agreed that there were communication problems, which he feels are due to the inexperience of the team. There is not a single senior on the team, and half are freshmen. He feels that there is a great deal of skill and potential to be developed, but until the players learn to talk among themselves he fears that they will be plagued with injuries, as they were in the last game, and unable to work together. The coach finds that it is difficult to work with players, many of whom, he says "don't WANT to cooperate, charging all the work to some," and making little effort themselves.

The Soccer team is fortunate in having an excellent coach who seems to be as concerned with the players safety, and that they enjoy the game, as with winning. But a few good players can't comprise the whole team. There doesn't seem to be much chance of them having a spectacular winning season, but if they can rid themselves of the internal disorders holding them back, the only way they can go is up.

Senate investigation of campus disorders may be heading for a setback if a suit filed by the American Civil Liberties Union (ACLU) in defense of the rights of the Columbia University chapter of Students for a Democratic Society (SDS) is successful.

Subpoenas have been issued by the Senate Permanent Sub-committee on Investigations to Stanford, Harvard, Cornell, Berkeley, and CCNY, as well as Columbia, requiring the universities to supply the names of all officers and faculty advisors of all campus organizations and to state how much federal assistance is being granted to them. The subpoena for Columbia also requires the records that identify all persons involved in the takeover of the university last year.

The political affiliation of the SDS members should be protected under the First Amendment. Also, the SDS claims that the investigations could not possibly serve any legislative purpose since no constitutionally valid legislation could be made, excluding federal aid or scholarships to people because of their involvement with campus political organizations or their convictions for illegal activities on campus. The CCNY faculty senate adopted a resolution declaring the CCNY subpoena was "intimidating and inhibiting."

Similar suits will be appealed on behalf of the faculty senate of the City University and City College of New York and nine individual professors.

On the 15th, concerned students and residents of the greater Hartford area plan to march from UHa to downtown Hartford to focus attention on the fact that, although numerous campaign promises were made, the election is over and no results have been forthcoming. This march should show the powers in Washington that no one wants this war, and that they should get off their dead asses and do something about

stopping it. I have asked many people if they are marching, and the usual answer is, "I'd like to, but . . You people are afraid to become involved. You think this march will turn into another Chicago, with police brutality and hippie, extremist, radical, Communist inspired fanatics taking over G. Fox's and turning it into a people's park. Don't be alarmed. The entire march has been approved by the city of Hartford. We won't even be doing any street fighting, so you can wear your good clothes. Everything is legal and above board, and parade routes will be posted well in advance of the march so everyone will know what's happening.

Some of the responses I received to my question were fantastic. "I'm sympathetic, but if I march, the federal government will cancel by student loan." How are they going to pick you out of 5000 marching people? "Well, if anyone sees me marching, and turns my name in to the school, I'm done for." This is a legitimate excuse, and could be solved in either of two ways: 1. You could wear a a bag over your head (preferably plastic), or 2. You could stay home and hide under the bed. Don't be ashamed to protest the Vietnam war (unless, of course, your family fortune is founded on napalm).

Another response I received frequently was, "Will there be many girls/guys there?" (pick one according to your preference.) The answer is, "Hell, yes!" Sex is no prerequisite for hating war. "There will definitely be representatives of both sexes present at all times." (direct quote from Alan MacMillan, staff writer for the liberated press.) Other schools marching with UHa will include: UCONN Hartford Branch, Trinity, Manchester Community College, and Hartford College for Women.

Remember October 15th, and do your part to help end the war in Vietnam.

photographers, and Chicago citizens in a ferocious, malicious and mindless manner" amounted to "what can only be called a police riot." This is the background of the "Conspiracy trial which began last Wednesday in Chicago

Eight leaders of the anit-war, anti-racism movement who represent the entire spectrum of American dissent in the past decade are charged with conspiring to promote a riot at the 1968 Democratic Convention. The defendants range from pacifist David Dellinger, 53, to white radicals Tom Hayden, Rennie Davis, Lee Weiner and John Froines; cultural revolutionaries Jerry Rubin and Abbie Hoffman, and Black Panther chairman Bobby Seale. The possibility of these men obtaining justice in a Federal Court in Chicago is virtually non-existent. The outcome of the trial is at least as rigged as the Democratic Convention.

Presiding over the trial is Judge Julius J. Hoffman, 74-years-old. The first day of the trial, Judge Hoffman proclaimed, "We do things very punctually in my court." Judge Hoffman is so concerned with punctuality that he has denied the defense a postponement so that Charles R. Garry, who has often represented Panthers, can recover from an operation on his gall bladder. Commenting on the fact that his defense is being unfairly hampered by Mr. Garry's absence, Bobby Seale told the judge, "If my constitutional rights are denied, I can only say that the judge is a blatant racist." (right on.) Judge Hoffman in an act to "intimidate and harass" lawyers. Two of these lawyers, Gerald Lefcourt and Michael Tigar, who had only been retained to file pre-trial motives had notifed Judge Hoffman by telegram that they were withdrawing from the case as they are working on the defense of the 21 Black Panthers being tried in New York City. But Hoffman had them arrested and held without bail over the weekend in the Chicago jail. This sort of police state repression gives some indication of the judge's concern for justice.

Bobby Seale and Jerry Rubin were driven from the West Coast to Chicago in separate cars. The trip took six days and all the while, they were handcuffed, with chains around their stomachs and shackles on both legs. They were kept incommunicado so that their lawyers were unable to effectively prepare their defense. Why is the Federal government so determined to rig this trial?

The defendants are being tried under Sections 2101-2 of Chapter 102 of the Civil Rights Act of 1968. The anti-riot provisions they are accused of violating were tacked on as a rider to the 1968 Civil Rights by Strom Thurmond, the man who gave President Nixon the electoral votes of the Southern states. This is the first case to be tried under this repressive law and as a Civil Liberties Union official says, it is "probably the most important political trial in the hisotry of the United States." The crucial issue is that of the clear violation of our First Amendment freedom to travel and express views to bring about social change.

Sections 2101-2 prohibits interstate travel with the intent to incite to riot. The frightening implications of this trial are that, if not invalidated, this law may become a very easy method to justify further police riots and imprisonment of those who protest that America has strayed from her ideals of liberty, equality and representative, responsive government. It is clear that what was started by Johnson and Daley in the streets of Chicago is being continued by Nixon and Attorney General Mitchell. It must be stopped.





























## Agitate, Educate, Liberate


We must fulfill our responsibilities. We must shelve our apathy. The bandwagon waits for us to climb aboard. Let us join in and raise our voices high.

### **Smith for Mayor of Hartford**

There is a cruel hoax now being perpetrated on the general public. We have had a deputy mayor attempting to upstage a vacationing opponent, using the tragic results of the conditions of our times to gain possible votes in the upcoming election.

You have a mayor who has really been on vacation for two years, struggling to regain the reins of status quo power.

And on the night before, we had political vacillation and delay on the part of the Council and its administration in dealing rapidly and decisively on the urgent situation. Seemingly, it was as if others intended to help in the past decade or more.

Ironically, it took the surface results of frustration, despair and hatred, in the form of senseless destruction arising out of hate and discontent to prove, that no revision of a city charter is necessary for a mayor to assert leadership.

It took this kind of civil disorder to prove that the City Council can take action when and if the members thereof desire, and that they CAN direct the City Manager to do what they desire of him.

The resolution calling upon judges to see first hand the damage that has been done -- before meting out punishment on those found guilty of committing wrongful acts -- should and must be amended to include visiting the squalor in which the majority of our non-white citizenry have been forced to live. Perhaps these judges will begin meting out stiffer punishment to the slumlords and their private counseling prosecutors in our local circuit courts.

None of us can condone the tragic acts and results of any riot. Whether it be here or in Northern Ireland. But those of us who truly deplore riots must come to recognize that they are forms of expressions of hate brought on by other expressions of hate -- poverty, frustration and the despairing feeling of rejection by the total society -- and we must also have the courage and wisdom to angrily confront those hatreds as well.

I'd like to take this opportunity -- not to campaign for votes, but to call upon all of our citizens, regardless of color or religion, to open up the legal and legislative avenues, and riots will disappear.

# Ann Uccello-Diplomat or Fool

This November, the Republican incumbent, for the Mayoralty race is Ann Uccello. Actively involved in politics since 1963, (Common Council 1963-1965 and Mayor since 1967), we must let Miss Uccello's record speak for itself.

The issue of education is a typical example of Miss Uccello's twofaced attitude. On September 27, 1968, Arthur Brouillet, President of the Hartford Federation of Teachers accused the Uccello administration of "consistently applying a meat cleaver to the school budget." When it had been discovered that \$800,000 had been cut out of the school budget, Miss Uccello supported a \$200,000 restoration of funds. Although she stood steadfastly opposed to the restoration of \$600,000 to the school budget, (\$400,000 of which was necessary for maintenance and equipment), Miss Uccello, apparently in good conscience considered herself a "fervent supporter" of educaton. This prompted Brouillet to state that "overcrowded, inadequate facility(s) stand as a mute testimony to her (Uccello's) voting record... The harsh truth is that the city is suffering greatly in many areas from the inadequate leadership of our Mayor.

Miss Uccello consistantly refuses to respond to the needs and sensitivities of poor people in Hartford. She was naive enough, on the night of Martin Luther King's assassination, to carry rosary beads as a "secret weapon" during her confrontation with leaders of the Black Caucus on June 4, 1968.

Twelve days later on June 16, 1968, Miss Uccello was present at the US Conference of Mayors. When the conference adopted a resolution favoring a federally guaranteed minimum annual income for poor people, the Resolution was finally passed during the second vote. Ann Uccello voted against the resolution both times.

Indeed, it may be said in all seriousness that the most important legislation during the Uccello regime has been the legislation for improved street lighting. She has consitantly shown a reluctance to relate to the needs of the urban constituency she purports to represent. She is unworthy to be mayor, indeed, unworthy to be Councilman. We urge that she be defeated in the race for Mayor in September. The issue is crystal clear.

If street lights are more important than poor people; if politics is more important than education; then it stands to reason that the politics of oppression is more important than the politics of humanity of justice. We must deal with the tiger of oppression. Ann. Uccello must be defeated.

# George B. Kinsella-The Get-Tough-on-Rioters Campaign

At the present time, the Deputy Mayor of Hartford is George B. Kinsella. He is interested in the concepts of law and order as opposed to peace and freedom. He advocates that the only way to approach the "problem" of riots is to "deal severely" with those responsible for the disturbances in the city. We submit that "those responsible" for the disturbances are the inept and corrupt officials controlling the decadent structure of Hartford politics. We submit that George Kinsella is one of those responsible.

Running on the platform of community renewal, George Kinsella was elected to the office of Mayor in 1965. However, it is clear that the only effective "community renewal" program of his administration was a plan to build a park in the city's South End. For this he was criticized by Rep. Leonard G. Frazier who stated that any new housing or community renewal project should be undertaken in the North End. First priority should be given to the Black Community of Hartford.

Racism. The issue is racism. Conscious or unconscious, overt or covert, this racism runs consistently through the mainstream of George Kinsella's political life. This is crystal clear.

As on August 14, 1966, when, as Mayor, Kinsella suggested that Hartford build some of its new schools in the suburbs and send city children to be educated in them. Thus efficiently ignoring the problems of urban education. Expecting urban blacks and whites to

relate to the racist nature of the suburbs. Leaving the people in the siums.

This is the same man responsible for a low and order approach to riots in Hartford. Who has vowed to "get-tough" on rioters and "deal severely" with this responsible.

This is the same man who accused black militants of forcing white businessmen to leave the North End. This statement was called a "blantant appeal to racism" by Glenda L. Copes of the Hartford NAACP. Repeatedly asked for evidence and "documented reports" he claimed to have, Kinsella had no response but to keep on making libelous and racist allegations. Representative Frazier stated that Kinsella should "put up or shut up." This is the nature of the man.

We urge you to examine the issues, the facts. Is this not the same man who, upon asking the Mayor about her views on the city budget, was told that he would know her views if he had attended at least one of the five budget meetings with councilmen and city manager Friedman. Is this not the same man who on September 4, 1947, was arrested on an alleged theft of automobile accessories? We submit to you that it is the same man. The same irresponsible harbinger of inefficient and inept bureaucracy the city of Hartford has ever known. His election must not become a reality. His campaign should serve as a reminder of a stagnant past and not of a free, flowing future of liberation.

Instead of a questionnaire, we propose a list of questions that elicit a true response from the applicant. With these questions we would be able to assure you that the watchman on the street will be giving you the best performance to his ability and our judgment.

EDITOR: When you last spoke at the University a few weeks ago somebody asked you how the so called civil disturbances could be stopped and you said that they couldn't because they were related to the conditions in the atmosphere. How would you describe the conditions in the atmosphere right now, after the disturbances right before

the elections? MR. SMITH: It's getting cool now and basically I consider that weather plays a hell of a part in the attitudes of people and pent up frustrations that people have. During the winter a lot of the people are not on the streets and you don't have the congestions and you lessen the possibilities that police are going to yell at you for loitering on the street. So automatically in the wintertime, the things that would normally set you off are removed by nature. If during the winter we do not change the atmosphere of city hall and in the city toward the non enforcement of the codes where people begin to see during peace that the law is good and willing to do what is just, then this means another winter of feeling and remembering the summer and the promises and what happened before. And to have time while you're freezing and paying that high rent and looking at those roaches crawling up the wall and try to board up the holes that those rats come in, only to move into another summer of having stood still and gone backwards and then to be run out on the streets because of the heat of the summer, only to have the watchmen tell you to move and something else starts up again. Plus we are having more children from the previous generation eating lead paint. With all of these things, how do you remove the prospect of youngsters growing up in a ghetto and who are ultimately going to suffer from brain damage? How do you do that? You enforce the laws. All of the riots in America which they call race riots are a rebellion of human beings against other human beings because of oppression.

EDITOR: In every urban community that has ghettoes and has black people there is this problem of communication to say the least between the tenant and the landlord. I have spoken to 4 or 5 people who are actually faced with the problem of eviction a) because they are Black or b) because they have long hair. I'd like you to comment on that.

MR. SMITH: Basically this problem of communication between landlord and tenant, there doesn't have to be communication because most of the landlords that we've come in contact with aren't necessarily interested in communication with tenants, they're interested in getting the money, for the rent. There needs to be an educational kind of thing, to advise people that 1) that laws do exist 2) you have rights and the avenues which you must take 3) a landlord's responsibility. I propose that the landlords must submitt a certificate of occupancy, that is to say that before any landlord rents a building it be inspected fully like they do for businessmen opening a store. Thereby when he passes inspection and is given the certificate, there will be no doubt that the house is fit for occupancy. And any damage done after renting will be the tenant's fault without any doubt.

EDITOR: I was interested in your success in getting whites involved in

MR. SMITH: We have many whites involved in the campaign. They are from all over, the suburbs, college campuses of course, and the high schools. Many people of the western parts of the city and some are from the southend. I think that I am going to have a tough time convincing the people that they need a change because of habits. I'm not going to say that I have the Black vote sewn up, but those people will vote for me because I am Black. And if that happens I will feel that I have failed to educate the people. You see that has been the problem with the past elections. People were not voting because certain people were qualified but because of what ethnic group they belong to, and their race and this has never gotten the people anywhere.

EDITOR: Do you have a final message for the people of Hartford? And could you tell them where they could reach you if they wanted to help you?

MR. SMITH: My final message to the people is to register. Then pay attention to the issues and the candidates and then vote from one's heart and mind rather than from fear and suspeicion. Then on November the 4th VOTE! # An Interview With Wilbur Smith

EDITOR: Mr. Smith, one of the things that I am dubious about as to your campaign is if you do achieve the office of Mayor, do you actually think that you will be able to exercise any kind of power in doing the things you want to do?

ANSWER: Let me say that it is not really a question of exercising any type of power. The question is whether or not a mayor has the ability to be concerned and the courage to do what the charter will allow that person to do as a mayor. For example, you heard much to do about the ceremonial post and many of the present people who have held the post before, like Mayor Uccello who is in it now for the past two years, and Deputy Mayor Kinsella who is now running as an independant saying that he wants to be Hartford's first strong mayor in the last 24 years. While this is a hoax that has been perpetrated on the public a revision in the charter that calls for a separate election of the Mayor, means nothing. The city Manager under the so-called new charter will still be the chief-executive officer of the city who will make all the appointments of department heads. The mayor is suppossedly still the ceremonial post except however the charter never did restrict the mayor to ceremony only. So while it still calls for the mayor to take part in representing the city in ceremonies, it does not restrict that mayor to that position. The ceremonial position of the mayor has been used as a crutch for people who have no courage, no vision, and no initiative about them.

EDITOR: How much of Ann Uccello do you think is hidden behind this thing, this ceremonial office? How much does she use as an excuse for not doing anything?

MR. SMITH: For the past two years this is all she's done. For example note that it's election time, and this again shows you lack of leadership, I'm positively sure that it was her backers who thought up the idea for to introduce the resolution to the City Council an ordinance dealing with the paint peeling situation where the Health Department discovered that over 100 of the youngsters were suffering from brain damage or lead paint poisoning. The resolution was to improve the conditions. But the council discovered suddenly that one George Ritter had introduced the same proposal a year ago and the problem arose as to whose resolution would be passed. Was it to be the Mayors or George Ritters? But no one is now concerned with the children who are suffering.

EDITOR: Would you say that the press has been guilty of not taking your candidacy seriously.

MR. SMITH: This is true and I don't know what we can really do about it except have our people contact the heads of the news media. It is true that from time to time they have called me the Black Liberal Party Candidate without racially indentifying the others. I was even labeled the North End candidate for mayor and Ann Uccello lives right around the corner from me so if I was that then so was she. But we appear to be getting around that, because it does cause a problem.

EDITOR: If you had to make a label for yourself what would you use? MR. SMITH: I am the Liberal Party Candidate for Mayor of Hartford. EDITOR: Just what does the Liberal Party mean?

MR. SMITH: Number one we had to designate a party by state law to go on the ballot. Basically it stands for being a hell of a lot more liberal, but what we mean by Liberal is being more just, than the other parties and the other candidates. What our Liberal Party stands for is in taking action to move the people in office into taking action to carry out the existing laws. In other words making Hartford a better place to live in and using the monies of the office for just that purpose.

EDITOR: Some of the candidates seem to think that the riots in Hartford could be stopped by a "get tougher" riot policy. I'd like to hear your comment on that.

MR. SMITH: These people are naieve and I don't think that they themselves believe it. This is a paradox. I think these people know what the fears are, they've built up a wall of fear of suspicion and distrust between the races and ethnic groups. This has become the stand to take if you want to be successful and elected. With the graft going on between the politicians and the labor unions and pedlers, this is success to them and the public doesn't see all of this but most certainly it is happening. Therefore the so called "get tough" phrase will only result in increased tensions and possibly more riots and larger riots, and only propel them even higher.


EDITOR: Is there any way you see of stoping the conditions? What do you think are the conditions that start a riot?

MR. SMITH: We have to look at the conjestion, we have to look at the conditions. If you were to examine some of the uncontrollable youngsters in our community, in the ghetto, you would find that some of these youngsters may be suffering from brain damage from having consumed this lead based paint. The other thing is the conjested schools that we have, the conjested communities, the high rents that are being paid by the

people the non enforcement of those laws that automatically and naturally would result in disrespect for law.

EDITOR: I would like your comment on last year in Hartford about the misunderstandings between Weaver High School and the School Board and student newspaper which Marcus Manzell ran. I'd like you to comment on the School Board.

MR. SMITH: The school Board is a political creature and subject to the whims of that majority that Mr. Adinolfi has already stated his intentions of going after and his belief that those are the people that must be satisfied. We would assume that this is the same judgement, and opinion of the people who also operate the School Board. As to the paper that Marc Manzell ran, there was supposedly a lot of opposition not to the passing out of the article, but they claimed that it was obscene and racist, which was



basically a lie. The fact is that he was never dismissed from school nor any of the youngsters with him, on the grounds that the paper was obscene and racist. He was dismissed supposedly for violating the principal's order forbidding its passing out on school grounds. He was also unjustly dismissed on those grounds because in order to support what the principal did, the School Board had to find something in their rules and regulation covering the principal's actions. So they came up with a board policy that stated that no employee or no commercial or sectarian organization or salesman could distribute or sell, the product on school ground. But he was neither. It was done because the Board of Education was pressured by school Teachers.

EDITOR: I heard you make a statement during your campaign that you would like to coordinate the police into the affairs of the community. I would like to know how you intend to do that?

MR. SMITH: The police department in their meager efforts, by the police department I mean the City Administration not the patrolmen and officers, to mislead the public or if we believe them, they have submitted a request to the Federal Government for funds to allow them to hire community workers who will be trained in police procedures to learn all about the police department. People who live in the who then can relate the so called problems of the police and in turn relate the problems of the community back to the police. Instead of going to the Federal Government, I'm saying utilize the resources we now have. And in this sense you could save the taxpayers 175 thousand dollars if we were to assume that the Federal Government was going to approve the grant. When you talk about police-community relations, your talking about being honest and open to the public. We are calling for Psychiatric treatment to see how much hostility is being vented through the job of a policeman.
