Duffey—Buckley

Last Thursday, October 24, the Matrix Fund of Trinity College sponsored what was billed as a debate between the Reverend Mr. Joseph Duffey and mr. William F. Buckley Jr.

The festivities opened with some opening comments by Mr. Miller Brown of the Trinity Philosophy department, introducing the two men. Mr. Brown also introduced the topic for the evening's debate: American Agenda for the Seventies.

The Reverend Mr. Duffey was the first to speak, giving a brief but concises synopsis of his views concerning the problems facing the American people in the coming decade. He listed the problems we have already been facing: the welfare problem, the problems of personal freedom, and the question of government intervention in said problems. He then made a point of re-wording them to apply to the coming decade calling them: the relationship of the individual to power, goals

and priorities. "We cannot move to issues of the seventies when the problems of the last three decades are still with us?" He told the audience that America has not yet solved the problems of economic order, reform, and the distribution of wealth and power, He told us that there exists now in America a "Crisis of spirit" which can only be solved by economic reform. Part of the reform he desires is an increase in the welfare program. He went on to say that the proverty problems of today are no different from what they were ten years ago, due to the "feeble fiscal attack on poverty" that was in no way a war, merely a "skirmish", and

Reverend Duffey finished by addressing a number of questions to the people that they should, in turn address to Mr. Buckley:

1. Why can't we reform the tax system so that everyone pays a proportionate share?

2. Why can't we check defense profits and put controls on prices? 3. Why can't we subsidise humanitarian functions instead of spending money on A.B.M. and the S.S.T.?

4. Why can't we guarantee a reasonable minimum income?

At this point, William F. Buckley Jr. took the podium. For the first eight minutes, he domonstrated his prowess at being a highly intellectual clown. He hit the audience with a brief, ad libed monologue of putdowns aimed at Mr. Duffey. Buckley is an orator par excellence and uses his gift to its best advantage. Instead of using his speech to air his views on the Agenda for the Seventies, he took this time to rebut most of what Duffey said. He spoke to the audience of the two trains of liberalist thought:

1. Help the poor

2. The poor are poor, because the rich keep them that way.

He calls this the "superstitious rhetoric of American Liberalism". He says that the liberals think (Continued on Page 11)

Bernard Hanson Named Dean Of Hartford Art School

Bernard Hanson, director of the Liberal Arts Department of the Philadelphia College of Art, has been named dean of the Hartford Art School of the University of Hartford, it was announced today by Dr. A.M. Woodruff, U of H chancellor.

Mr. Hanson will assume the deanship on February 1, 1970, and will become the academic and administrative head of the Hartford Art School.

"As an art historian, teacher and administrator with an extensive understanding of art school studio programs, as well as beckground in liberal arts, Mr. Hanson will bring to the Hartford Art School a rare combination of experience," said Dr. Woodruff in announcing the appointment.

The Hartford Art School, founded in 1877, was one of three established institutions of higher education which joined in 1957 to form the University of Hartford. The university, located on a modern 200-acre campus, is a private, coeducational urban institution with a total full-time enrollment of approximately 3 000

Last spring, Alan Tompkins, director of the Hartford Art School for 12 years, asked to be relieved of his administrative duties at the school to enable him to devote more time to painting, teaching and lecturing. Mr. Tompkins, presently on sabbatical leave, will continue to serve as vice chancellor for the visual arts at the university.

In accepting the position, Mr. Hanson noted that he believes "the present and past in art must be examined with great care so that what is desirable and pertinent can be retained and that which is not can be dropped. The future, which is what education for the artist is concerned with, must be based on the past but it cannot be a simple attempt to

re-create what has already gone

before."
Mr. Hanson, 47, was born in Williamsburg, Iowa, and received the Bachelor of Arts degree in English and the Master of Arts degree in art history from the University of Iowa. He did advanced graduate work in art history at the Institute of Fine Arts at New York University and at the University of Pennsylvania.

He joined the faculty of the

Philadelphia College of Art in 1959 and was named head of the Liberal Arts Department in 1965. He taught previously at Northwestern University, from 1944 to 1945; the University of Florida, 1947-57, and the University of Pennsylvania, 1957-59. In addition, he has taught summer session courses at the University of California at Los Angeles and at the University of New Mexico.

Twice in the recent past, Mr. Hanson has presented papers at the annual meeting of the College Art Association, and in 1967 was

1-A-0 vs. 1-0

Dear Mr. Bresnick,

Having read your letter I was pleased with your feelings against the present draft laws. However I disagree with your statement about deferments. You say that application for a Conscientious Objector's deferment is the biggest moral cop out of all time. First I think it should be made clear as to what a CO really is. There are two parts to this deferment. The first, the 1-A-O. This is volunteering for non-combatant duty in the armed services. This is generally medical duty in combat-ant zones. The second type is the 1-0 deferment. This two years of civilian work "in the national interest.

You say that accepting a CO is accepting the system, thereby con-doning the murder. This is true of the 1-A-O deferment. The 1-A-O, by accepting duty without a gun, only leaves a spot open for another person in the system. However the 1-0 is in no way connected with the armed services. He may chose an assignment he feels is in the national interest. This assignment is not necessarily accepted. If you feel that a person cannot work for his country in a constructive manner and still disagree with certain policies of that country, you are a stubborn fool. A country cannot run by itself. Each capable citizen is responsible for at least those two years of constructive service. I too have registered an application for such a 1-O deferment and am anxious to begin my service to my country in a constructive manner rather than the destructive one that so many people blindly accept by working in the armed services.

The Hawk defense, as it has so many times this season, came up with the big plays when they were needed as the UHa football club eaked out a defensive dual win Pace College, 10-8.

The Hartford defense set up the only touchdown for the scarlet and white on a first quarter Dave Wall interception which he returned twenty yards to the hometeam Pace's 5 yard line. Two plays later Dave Smith went through left guard for the score giving the Hawks an early and short lived lead. The conversion was good on a Mark Adams to Tom Sanders pass.

The Setters from Pace came back quickly at the beginning of the second period as the devastating combination of QB Dennis Carpenter to end Bob Dickenson began to click. The Pace drive began on their own 40, but they quickly moved downfield all the way to the Hartford 5 yd. line before they were momentarily halted.

The Hawk defensive front line stopped the Setter runners cold, but on fourth down, Carpenter found his favorite target, Dickensen, standing by himself in the corner of the endzone and the men from White Plains were on the scoreboard. The two points safety and the Hawks fourth tying the game were tallied on a Carpentor keeper and it was a new ball game.

The defensive play in this contest cannot be overemphasized because it was here that the game was won and lost. Continually, one club or the other would move the ball inside the opponents 5 yd. or even 1 yd. line only to falter when confronted with an inspired defense.

It is not right to single out individual members of the Hawk defensive team because in the words of coaches Raly Worth and Dan Lawlor, "All of the boys in that defensive unit were dynamic.

Coach McCullough is hopeful that veteran Wayne Augustine, a 6-8 senior from West Hartford, Connecticut can move into the center slot. Another candidate is John Dufault, 6-4, 200-pound sophomore up from the frosh, who may help to fill another vacant forward post left by Howie Busse. Dufault led the UofH frosh last year in scoring and rebounding statistics.

Co-captains Dave Brunelle, 6-2 forward from Newington, Conn. and Larry Franciose, a 5-10 guard from Barre, Mass., both seniors. have reported back with strong credentials while scoring 12.6 and 11.7 points per game, respectively, last

Edward Dunn, 6-1 senior guard

from West Hartford, and Ronnie Berger, 6-2 junior guard, each averaging better than 7 points a game in 24 contests last season, provide a solid nucleus for a strong year on the UofH hardwoods.

Other returning lettermen include Richard Kuhlbars, 6-2 forward from Dumont, N.J.; John Seabury, 5-9 buard from Plantsville, Conn.; and Gregory Turek, 6-3 forward from Wapping, Conn., who is counted on for added offensive strength.

Newcomers to the squad are two transfer students in Tom Mead, 6-2 forward from Yonkers High School, and Fred Tyson, 5-9 1/2 guard from Wilbur Cross High School, New Haven, Conn. Both are 1967 high school grads with two years of junior college play in their court experience.

The Hawks will play Bowdoin College in first round play of the Central Connecticut State College Tournament on Friday, Jan. 2. Central will meet Wesleyan University in a second game that day with finals coming on Saturday, Jan. 3, at the New Britain, Conn. School.

Hartford will open their season at home on Tuesday, December 2, against the Springfield Chiefs in an 8:00 p.m. game at the UofH Physical Education Center gymnasium.





Rent Strike!

Why is there really no decent housing? Ask yourselves that question, because of the system, and what it has done to Black people in the four hundred years since we've inhabited this continent - this United States of America. The system has robbed us of manhood, self-pride, initiative and motivation, and most of all, of our black frame of mind. The result is our present condition, which is perfectly obvious, if one just opens his eyes to see what's going on around him.

What is perfectly obvious to us is that the system has done its job well by brainwashing the people in the community. They've concentrated us in the ghettoes, or, as they prefer to call it, low-income housing. Tell

me, who in the hell is going to have pride in living in a low-rent project with what seems to you every other person in the world crowded in on you? They've told us that any job is good enough for us, that cleaning up whitey's house and feeding his well-dressed children should make us glow with happiness and pride in ourselves, and that it's nothing to come home to a dark, cold, rat-infested two-room apartment and six kids who are ragged and hungry. That Black skin is dirty and smelly, and that we are incapable of feeling deeply, learning, or giving anything valuable to society. After centuries of being fed and drilled on this shit, how are people supposed to truly believe that they are human beings of worth? How can a Black girl look in the mirror and think anything other than that she is ugly and fit only

for white men in dark corners? So, when one looks at a ghetto, think on the reason for its being. Consider awhile why it is not spic and span. When there is no reward or pride in keeping something clean and shiny, why expend yourself to do it, especially if there are more important things to be done like working ten hours a day to feed your children. When oppression is protested by black people, they are told that they have "so much;" that they should be happy with what they have. They are asked why they should want anything more, and if they complain, they are told to shut up; and if they don't, they get kicked in the teeth. A rent strike is a group of people organized to protest the high cost of rent and housing conditions. Its purpose is to bring about lower rent and improved living conditions. This group can be either incorporated or unincorporated, and is frequently backed by a lawyer or legal service.

There is an ongoing rent strike at 188 Bellevue Street. The strike began in July, and the landlord

finally started improving around the beginning of September. We spoke with one of the tenants at 188, who stated that the strike was mainly in protest of the extremely dilapidated state of the apartments and the entire building. There were large holes in the walls, broken electrical fixtures with bare wires sticking out, lead base paint on the walls (which contains a deadly poison), the stairs were very unsafe, and there were rodents and trash. The landlord has since given tenants paint with which to do their own apartments and he has had a few plumbers in to do some work. Some of the holes have been filled in, and best of all, he has raised the rent.

Bellevue Square, right across the street from 188, also has very poor conditions, filthy hallways, small inadequate apartments, cement areas instead of grass where the children play, glass all

over the place, and rather high rent. This project is classified as low-income housing, but the rent rate is not in accord with this category. Since Bellevue Square is a federal housing project, there is no forseeable means of initiating a rent strike. There are five hundred and one units in the Square and approximately. (from statistics at the offices of the Community Renewal Team) 5 to 6 persons per unit. This makes for a figure of about 2505 to 3006 people living in one city block.

All other low-income housing projects, as well as the whole North End is victim to the above-mentioned conditions. Now, one would think that with all the damn progress centers and agencies (there's one for almost every block in the North End) that something would be happening to change this horrible

Rent Strike!

For the Legal point of view on rent strikes, TOGETHER interviewed Eliot G. Striar, Senior Staff Attorney with Legal Services on Barbour Street in Hartford. His remarks, as interpreted by our reporter, were as follows: The main force behind a rent strike is, of course, economic. If a large percentage of tenants in a given building will bind themselves together, tightly enough there are innumerable things to be gained from this manner of negotiation with a landlord. There are two ways to conduct a rent strike: legal and illegal. To make a rent strike legal, the tenant association that is formed must go to court and request that a receivership be set up in which the court would take all monies paid for rent and hold them for the landlord and tenants until an agreement can be reached between them. There are very few states where legislation has been passed for court receiverships to be instituted. The key places where such has been tried are New York, Washington D.C., Michigan, Massachusetts, and Illinois. Connecticut has a weak receivership set-up, but rent strikes have been very sporadic.

Three laws relating to housing in Connecticut have been passed, and are effective as of October 1. 1969. The first is Public Act 728. This bill sets up a tenant representative for the circuit

mess. Instead, these fine centers with their facilities for dealing with enforcing the housing codes might as well be totally nonfunctional. For instance, the North Arsenal Neighborhood Development, which is directly

across the street from 188 Bellevue, is contradicting its own policies and guidelines by misrepresenting its aims to the people in its target area. North Arsenal has proposed a housing project consisting of 192 units, including a 6 story hi-rise building, all with 3, 4 and 5 building, all with 3, bedrooms. This will take up a whole city block. North Arsenal has neither the funding nor the people and facilities to produce such a complex.

Included in the list of city agency progress centers are the following main centers: Northeast-Stowe Village, Garden South Arsenal Neighborhood Development, North Arsenal Neighborhood Development, Clay Hill, South Green, Sheldon Charter Oak, Charter Oak ABC and Charter D, and Bellevue Square. Each one of these has proposed to deal with the question of housing, and each has resulted along the same lines as North Arsenal. None of these agency program centers have any idea of where the money is coming from to support these intentions. In essence, what these agencies are doing is giving the people false dreams to live on.

Basically, what we're trying to say is that 1) children are the foundation of the future, therefore 2) children should NOT be forced to live under such conditions as they are in Hartford or any other city. What they need is lots of grass, trees to climb, puppies to play with. What do

Liberal Party Platform

No platform, however formal and detailed its proposals, can or will do more than possibly evidence the word-skills of a candidate's speechwriting staff and the ideas of experts available to that candidate in the number of professional positions which make up the total package called "city government."

Platforms are traditionally presented, published, filed and for the most part forgotten. The Liberal Party platform is an exception. It contains not promises, but evidences of many proposals which have already proven successful on a smaller scale in Hartford.

We are sure our platform CAN re-stress to the voters of Hartford that (1) the city's governmental structures are meant to SERVE the citizens of the city, and (2) that failures on the part of governmental structures are NOT the fault of city charters, laws, codes, resolutions or proclamations - but the more serious and insidious failure of the people involved - to provide the personal courage and individual leadership without which the city of Hartford can only destroy itself.

If the city is to breathe free of distrust, alienation and fear again, it can only come from the efforts of all the people of Hartford working together under strong leadership to MAKE it happen. We are confident it can be done, and I proudly submit this platform as a basic outline for our beginning to do it -- if the voters of Hartford so choose.

I submit one of the central issues the people must consider is that of responsible leadership.

We will continue for the remainder of this campaign to expose the hoax that our opponents are perpetrating on the public. The hoax is - that recent Charter changes will guarantee a stronger Mayor than the present Charter provides. This is a fabrication of the lowest order.

In reality, the newly-revised Charter does not change the fact that the City Manager remains the Chief Executive official and the City Council, the legislative body of final authority.

Our present Charter, though in dire need of modernization, in no way alters the fact that both under the present Charter and the newly-revised sections, the person occupying the office of Mayor could - with wisdom and courage -- lead our city to greater accomplishments.

It is to be a maxim of our campaign that we shall not criticize without offering constructive remedies. Therefore, we would propose, as stated in our formal platform, that we

There is today in our city much ado about Law and Order, rather than Law and Justice. The supporters of the Liberal Party submit that where there is justice in the administration and enforcement of law, order should naturally follow.

EDUCATION:

In years past, Hartford schools were rated as top-flight learning institutions. Today we find many families leaving the city largely in the belief that our city has an inferior school system.

The problems faced by today's educators are not those of ten vears ago. The ethnic background and life style of many of today's students requires a different approach to teaching. The generation gap that separates today's parent and child is small, relative to the chasm between the

student and the system in all Hartford's schools. The major problems of education can be summarized in a single word -irrelevancy.

We recommend the Mayor assume a LEADERSHIP role by establishing an Educational Advisory Committee which would meet with him on a regular basis. This committee would be composed of parents, students and teachers from ALL areas of the city. Anyone volunteering to serve on the committee would be welcome. In addition to voluntary membership, the Mayor should actively seek out and encourage membership from the Chamber of Commerce and already-formed community groups. This would allow the Mayor to truly assume a leadership role in Hartford's educational future.

We further propose that the City Council recommend to the Board of Education that Consumer Education and Protection be integrated in the curriculum of students from grades 4-12, and an expansion of vocational (industrial) education programs in Hartford which offers youngsters direct flow into the job market.

SOCIAL SERVICES:

Hartford, as most other large cities in transition, finds itself faced with a critical need for health and welfare services.

The Liberal Party endorses both of these principles. To us, this is where the rubber meets the road and neglect in this area, as we have seen, can be much more costly in lives, attitudes and dollars than one can imagine.

We recommend:

- 1) The recruitment of Spanish-speaking persons to be hired and trained in all areas of social services;
- 2) Immediate implementation to construct badly-needed day care centers, and
- 3) That greater efforts be undertaken to treat and rehabilitate youthful drug

offenders. Initial intake centers must be established in Neighborhood Centers, hospitals and schools, with patients then being referred to state and local treatment centers. HEALTH:

Hartford has four hospitals that serve the larger portion of northern Connecticut. In regional discussion, leadership will be taken to assure proportional help from the surrounding towns to defray costs incurred in providing city services to these tax-exempt institutions.

A. We propose to provide leadership to efforts at coordination of existing health care facilities both public and private. In particular, expanded out-patient services in neighborhoods adjacent to the hospitals are needed.

B. We support legislation to broaden the authority of the State Health Commissioner to accomplish this coordination of services.

C. Lead Poisoning - The enormity of the lead poisoning among children can be and many times is, as big and as grave as the slum-housing problem in a community. Hartford has slums. Hartford, as reported recently by health officials, has children suffering brain damage from consumption of lead-based paint.

A recent health study of children residing in slum-dwelling units in Hartford disclosed many had more than normal amounts of lead in their blood. This was directly attributed to lead-based paint poisoning.

D. The related problem is the manner in which both major party leaders reacted to the above-stated disclosure; the bickering over which ordinance should be considered -- the one submitted by the Republican or the one submitted by the Democrats one year ago, referred to committee and never acted upon -- all of which indicated total disregard and irresponsibility by both parties for the plight of the afflicted children.

The Liberal Party supports the position of the City's health director that the City Charter presently "...empowers the director of health to order the removal of hazardous health conditions inside dwelling units," and that the solution of both problems rests in ENFORCE-MENT OF EXISTING LAW PARKS AND RECREATION

We envision the establishment of a Consumer Advisory Committee composed of a cross-section of the community, such as housewives, teachers, representatives of neighborhood groups, the Better Business Bureau and labor organizations. TAXATION:

The City of Hartford is facing a serious financial crisis. It will need additional money to pay for the services required to improve, for example, the educational, housing and protective services our citizens need. Therefore, the issue facing us is not WHETHER we need more taxes, but HOW we can raise the needed revenues in a fair and equitable manner to meet this financial crisis.

After considering the various alternatives available to us, our basic approach will be three-fold:

1. We propose:

A continuation of the property tax freeze on the elderly citizens of our community. To abolish this tax freeze for the elderly would be to unfairly penalize a group of citizens who live on fixed incomes, and

state-administered personal income tax as the only fair and equitable tax available.

3. The levying of such a tax would allow the State to reimburse or give "block" grants to the City, so we can meet our pressing needs; the expansion of our revenues in this fashion would property taxes.

court. If a majority of the tenant's in a building file an application of complaint (re-housing violations, rent rates, etc.) with this representative, he will look into the complaint, and if justified, will then have a hearing with a referee. If the referee finds the complaint valid, and the housing conditions were not caused by the tenants themselves, then the representative will ask the court, by petition, for a receiver to be appointed and the rents subsequently held. Another bill passed may, however, cause great conflict with this law where rent strikes are concerned. The State Welfare Department has been authorized, as of October 1st, to make direct payments to landlords if the rent is in arrears past ten days. To make a receivership rent strike profitable, the tenant association must approach the Welfare Department and negotiate with them before the rent is actually in arrears. If the Department does not 2. We pledge: cooperate, the whole purpose of the strike will be defeated.

Public Act 315 is an enforcing act, and goes hand in hand with Public Act 728. It makes retaliating evictions by the landlord illegal. For instance, if a tenant reports housing code violations to the proper authorities, a landlord now cannot evict on these grounds. Public Act 390 is an act giving an implied covenant of habit ability and parol lease (oral lease). Of old, if there were repairs to be done in an apartment, unless so stated in the written lease, the landlord was not obligated to do whatever was necessary in preparing an apartment for tenants. Under this act the accommodations have to be, basically, in a liveable condition. Public Act 390 can be used as leverage for a strike, but is, as yet, untested. Attorney Striar ended the interview by stressing the importance of combined economic power, and the fact that these acts will not be adequate vehicles for change unless people get together, sacrifice, and are willing to take gambles.

everything has one simple solution: send the bill to Washington. By so doing, the dollar is "baptised with a sense of social difference" because it has gone from the people to the government and back again. He finished his round by asking who could "come up with something better than that which produced the relative squalor of the sixties".

The reverend Mr. Duffey now spoke, opening with a jab at Mr. Buckley's verbocity. He then accused Buckley of a "rash disregard of facts" when speaking on poverty. He then verballized the fear that the rich have, that the poor are grabby, and said that those who have inherited wealth shouldn't knock those who are attempting to better their circumstances.

Buckley answered this by saying that "Mr. Duffey is...driven into desperation". He spoke then of the red scare, and the fact that the liberals complain about defense spending, but, "isn't it worth 10% of our weekly paycheck to keep the barbarians at bay?" We won't have any ghetos to clean up if we are no longer free.

Mr. Duffey's only answer was a question: "Is that what we're doing in Viet Nam?"

There followed a question and answer period from the audience in which Mr. Buckley had another chance to demonstrate his wit, calling the Moratorium a theatrical success, and nothing more.

Concerning the techniques of both men, Buckley has much more style when speaking. Although Duffey is very structured in his speeches, Mr. Buckley was more than able to pull the rug out from under him.

co-chairman of that meeting, with responsibility for the artist-teachers program.





A Plea for Reason

A Letter To The People

Ladies and Gentlemen:

In addition to my message to you this evening, on behalf of the many persons actively involved in our campaign and the unknown thousands who will vote with us on November 4, I extend our deepest appreciation to Channels 30, 24, 18 and 3 for providing me the opportunity to speak to you.

What I say this evening is not directed solely to the voters of Hartford who will cast votes on Election Day, but also to those of you who have chosen for your own reasons not to register, those who may be registered-but may feel you have no reason for which to vote, those who may unfortunately be unable to vote because of some physical handicap-and lastly, to our youngsters in our elementary and high schools and colleges not yet old enough to vote.

We are at a point in the history of our city where we must make critical judgments and vital decisions-both collectively and as individuals. Our city has enormous problems-as does every major city in

Our schools are obsolete; our streets in disrepair; our business and industry are subject to manpower shortages, the pressures of inflation and the impact of conglomeration; our police force is embattled from without and embittered from within. Our need for adequate housing at rents and prices proportionate to the people's income, is crucial; our shopping facilities are inadequate; recreational outlets deplorable; hospitals understaffed and so overcrowded that often you are forced to wait weeks for a bed; and our provisions for the poor, the young and the aged are disgraceful.

At the same time, our city government lurches along the highroad to financial insolvency between inertia and desperation, utterly bankrupt in the realm of imagination and totally devoid of any true sense of leadership.

In order that we accomplish our aims, we must first consider the most critical issue with which we are confronted.

We are told the problems lay with the "old" Charter—that the answers rest with the "new." That the "old" position of the Mayor is largly ceremonial. That the new provides considerably more power-and that THAT makes the difference.

Nothing could be further from the truth!

Under the "old" Charter AND the So-called "New," the Mayor is given a ceremonial role. But the powers and duties of the Mayor have never been confined to ceremony only.

The person occupying the Mayor's seat under the old Charter, as in the so-called new one, could "...recommend and introduce such ordinances, resolutions, motions and other measures to the Council as he deemed necessary or expedient,"

Likewise-the Mayor could act as the principal representative of the City in relations and affairs with the United States of America, any State government, other municipal governments, and any subdivisions, departments or agencies thereof.

The argument is advanced supporting the so-called "return partisan politics and the 'ability' to pinpoint party responsibility." This argument is an insult to the intelligence of every citizen of this city.

Partisan politics, indeed! I submit that partisan politics is the root CAUSE of the degrading situations in which we find ourselves. Smith Responds To

Health Care Statement

Wilber G. Smith, Liberal Party candidate for mayor, today responded to a recent Hartford Times statement by Republican council candidate, Mrs. Margaret T. Tedone, regarding city health care services.

Smith stated: "On October 7, the Liberal Party platform proposed '...to provide leadership efforts at coordination of existing health care facilities both public and private. In particular, expanded out-patient services in neighborhoods adjacent to the hospitals.

Smith congratulated Mrs. Tedone for "sharing the Liberal Party's concern for immediate and effective neighborhood health care," and expressed his hope that the remaining roster of Republican as well as Democratic candidates would join him and Mrs. Tedone in emphasizing to the voting public the critical problems of health services in Hartford.

Thoughts on the Duffey—Buckley Debate

As with the famous Kennedy-Nixon "debates" of 1960, this was no debate at all. There was not even a common universe of discourse which, to be sure, is the norm with Mr. Buckley who lives in his own very special universe, reserved for the very special few.

Mr. Duffey opened the proceedings with a direct response to the topic under consideration: "Issues of the '70's." In essence, he argued that poverty, racism, unliveable cities, pollution of the environment, the quality of medical care, etc., were unacceptable in an affluent society such as ours IF we have any pretensions to decency. And he related the muddle-minded involvement in Viet Nam-and consequent

misapplication of resources-to the continuing tragedy of American life.

Mr. Buckley, with his undeniable talents for superior male bitchiness-the only masculine counterpart of Clare Booth Luce with which I am acquainted-registered higher on the laugh meter, but scarcely responded to the issues. As anyone who has followed Mr. Buckley's career as a leading spokesman for what has been euphemistically described as neo-conservatism knows, he is so infatuated with William F. Buckley and his dazzling rhetoric that he cannot be bothered about matters of substance. Hence, true to the style he has been displaying since GOD AND MAN AT YALE almost 20 years ago, he chooses his own facts within a frame of reference that, to say the least, is rather esoteric. It might be summed up in a phrase, "I've got my inherited pile and I will fight to the death any attempt to redistribute income in this country." This, of course, represents a kind of post industrial Social Darwinism that, to put it mildly, comports illy with the Thomistic philosophy of the faith to which Buckley so pretentiously adheres. My father warned me against those who "tell their beads" in public; Mr. Buckley lends substance to his admonitions.

In short, the Reverend Mr. Duffey is my friend, not merely because he is a good human being, but because he is a man who is attuned to the times. He lead us through the McCrathy campaign last year with unflagging vigor, good sense, and commitment: who could ask for anything more? I hope John Bailey gets the message.

As for Mr. Buckley, much as I mistrust the argument AD HOMINEM he deserves it; the style is the man, even though in his case it is evidently vice versa. I am reminded of a distinguished review article of an "authorized" biography of Clare Booth Luce, written by Marya Mannes in REPORTER somy ten years ago in which she suggested that Mrs. Luce had intelligence, beauty, wealth, talent, charm-and no

they have in the North End? They have all the hard cement their little hearts could possibly desire all the glass in the world to bruise themselves upon, all they see is broken, crowded buildings, oppression and suffering. What kind of philosophy can possibly be formed from living in this sort of a world day after day? What happens when these children begin to grow up and realize that not everybody lives this way? Slowly a pressure begins to build up inside them and it grows and grows with the oppression of living in a ghetto. It grows and grows, and one day, it explodes. It's happened in Watts, Chicago, Newark, and on a small scale in Hartford. But Hartford has not yet had its day. If you whiteys in the government, and you whiteys in West Hartford and you whiteys on campus (and that includes you too, Black folk) don't start doing something constructive in league with the survivors of the North End, you'll be in very sad shape when the explosion comes ... and it's just around the corner ... friends
